PROCEDURE SUMMARY

Texas A&M AgriLife Research (AgriLife Research) accepts formal agreements for the loan of equipment or animals with the purpose of furthering AgriLife Research projects in connection with the associated equipment or animals. Such agreements are entered into with the use of Texas A&M AgriLife (AgriLife) forms AG-104, *Loan of Animal*, and/or AG-105, *Loan of Equipment* subject to approval by the director, or designee, and unit head. AgriLife signatures serve only as an acknowledgment of receipt of the loan, and do not represent concurrence with any stated value of the item.

This procedure outlines the process for AgriLife Research acceptance for the loan of equipment or animals.

PROCEDURES AND RESPONSIBILITIES

1.0 LOAN AGREEMENTS

- 1.1 For all loans, submit completed form AG-104, *Loan of Animal* or AG-105, *Loan of Equipment* (as appropriate) to the AgriLife Contract Office for processing at contracts@ag.tamu.edu or

- 1.2 The principal investigator or supervising individual must acquire the signature of the lender and unit head before submitting the document to the AgriLife Contract Office.

2.0 RETURN OF EQUIPMENT OR ANIMALS

Upon the end date of the agreement, or upon return of the equipment or animal if sooner, the unit will be responsible for notifying the AgriLife Contract Office that the equipment or animal has been returned to the lender.

3.0 RECORDKEEPING

The final agreement and other associated documentation will be filed in Laserfiche or Maestro and retained in accordance with the records retention schedule.

DEFINITIONS

AG-104 Loan of Animal: The *Loan of Animal* is a formal agreement document for the acknowledgment and conditions for the loan of animals. AgriLife administrators' signatures serve only as an acknowledgement of receipt of the loan, and do not represent concurrence with the value stated by the donor of the item loaned.

AG-105 Loan of Equipment: The *Loan of Equipment* is a formal agreement document for the acknowledgment and conditions for the loan of equipment. AgriLife administrators' signatures serve only as an acknowledgement of receipt of the loan, and do not represent concurrence with the value stated by the donor of the item loaned.
