#### **Job Summary**

The Chief Response Training Coordinator, under direction, serves as a member of the Texas Forest Service (TFS) Incident Response Program leadership. Provides supervision, leadership, and direction of the TFS emergency response training programs, including internal and external training courses and academies. Interacts with cooperators and stakeholders at the local, State, and National level.

### **Essential Duties and Responsibilities**

- Ensures professional development of personnel and training staff. Manages and provides input on employee training, course development, employee development planning, policies, and strategic direction. Ensures compliance with policies, procedures, and reporting requirements.
- Assists, delivers, and manages special projects as assigned. Produces reports and presentations and serves as a professional representative for assigned departments.
- Supervises field delivery of wildfire and all-hazard emergency management training programs to fire departments and other emergency response entities.
- Provides leadership and promotes interaction with emergency responders, community leaders, and citizens.
- Promotes training programs and other initiatives that increase response capabilities at the local, regional, and statewide level.
- Maintains appropriate educational standards through periodic evaluation of programs. Provides
  oversight in the administration of assigned personnel and ensures successful delivery and support of
  additional programs and projects.
- Directs, trains, develops, and evaluates personnel. Identifies professional developmental needs and ensures development of permanent and additional duty staff.
- Ensures compliance with loss prevention, environmental health, and safety standards as established by applicable laws and rules.

This document represents the major duties, responsibilities, and authorities of this job, and is not intended to be a complete list of all tasks and functions. Other duties may be assigned.

Basic TCFP Firefighter or SFFMA Firefighter II or (Accredited Advanced Firefighter certification issued prior to January 1, 2012), and TCFP or SFFMA Fire Instructor II certification.

Physical Requirements – Ability to exert moderate force.
