1-Cup Liquid Measuring Cup

- Sturdy plastic, dishwasher safe
- Pouring handle
- Includes standard measurement: millimeters, cups and ounces printed in black
- Color: Clear (Measuring Cup)
- Imprint on side, EFNEP logo
- Imprint Color: Blue
- Imprint size: 1.5" H x 1.75" W
- Imprint: One color/one location (under pour spout, EFNEP)
- Quantity: 7,500

- Freezer-Friendly

PRICING:

- Price of each item should include any applicable artwork and setup fees.
- For comparison and evaluation, all items bid must be as specified in each line item as well as the pictures in the attached.
- Vendor may be required to provide samples of item being bid at no additional cost.

SHIPPING:

- All shipments to be F.O.B. destination. Vendor maintains ownership in transit until delivered to its' destination. Please specify any shipping charges on your bid submittal.
- Items will be shipped to the nine (9) addresses listed in the shipment information document below with the associated quantities.
- Due to the quantity and variety of items being requested, the Agency anticipates that not all line items will be fulfilled within the same time period. Rather than delay shipment until the entire order is fulfilled, the Agency requests that shipment occur once each line item order quantity is fulfilled. For example, cutting boards should be shipped to their respective shipping addresses as soon as all 7,500 are ready even if the water bottle line item is still pending.
- Locations do not have access to a loading dock or forklift and cannot accept palletized shipments. If palletized shipments are sent, vendor/freight carrier will be responsible for removal of shipment from palletized container and break down the shipment into boxes that can fit through a standard door frame at time of delivery. Otherwise, the agency reserves the right to refuse delivery at no cost to the agency.
- Delivery time frame should include the amount of lead time items would be available for shipment after receipt of a purchase order. Vendor's bidding document must list the delivery time frame in order for vendor's bid to be considered.

IMPRINT:

- Logo will be provided to awarded vendor with issuance of purchase order.
- ***All item imprints, size, color and location must be approved by agency point of contact by digital artwork mockup prior to filling order.***
