- (b) Upon the Agency's written request, the vendor will provide specified public information exchanged or created under any resulting Agreement that is not otherwise excepted from disclosure under Chapter 552, Texas Government Code, to the Agency in a non-proprietary format acceptable to the Agency. As used in this provision, "public information" has the meaning assigned Section 552.002, Texas Government Code, but only includes information to which the Agency has a right of access.
- (c) The vendor acknowledges that the Agency is required to post a copy of any resulting fully executed Agreement on its Internet website in compliance with Section 2261.253(a)(1), Texas Government Code.

Warranty: Any quote submitted should include complete warranty information for the items being offered.

<u>Delivery</u>: Must be delivered no later than July 1, 2018. Any quote submitted should include delivery time for the items being offered.

Award Based on Best Value: Texas A&M AgriLife Research reserves the right to accept or reject any or all quotes, to waive informalities and technicalities, to accept the offer considered most advantageous and award based on best value criteria. In determining what is the best value to the Agency, the Agency shall consider any or all of the following:

- 9) any other relevant factor that a private business entity might consider in selecting a vendor.


Bidders are encouraged to provide any and all information they believe may be helpful in determining the best value to the Agency include information directly related to the above-mentioned criteria.

Custom fabricated panels per the following specifications:

- Frame to be constructed of primer coated 3/4", 14-gauge square tubing
- Frame must be constructed, and measure, as detailed in the diagram below



- 2' x 6' sheet of 16-gauge, galvanized welded wire with 1" x 1" mesh shall be secured to each frame with #10 x 3/4" self-tapping screws and 1/4" x 1" fender washers, except for in the 1 1/4" gap in the frame
- Wire shall only cover the bottom 6" of the 1 1/4" gap in the frame
- The photo below is of an existing panel the Agency wishes to replicate. This should be used as a visual reference only. All panels should be fabricated using the measurements listed above.
